

Education Assistance for 2017

This document sets out the application criteria and process for the Namosi Joint Venture's (NJV) Education Assistance Programme (EAP) for 2017.

The EAP is aimed at students from the province of Namosi and Tikina Waidina, Naitasiri who need financial support to attend or complete relevant tertiary education or vocational courses in Fiji.

The EAP runs for one year. NJV considers each year whether to run an EAP. The number of students assisted may vary from year to year.

Applications for 2017 Semester 1 assistance close on 24 February 2017.

Lodging an application does not mean that you are guaranteed assistance.

Selection criteria

1. Applicants must be aged between the ages 18 and 35 years at the time of application.
2. All applicants must fill in the Semester 1 application form and provide the required documents (official invoice/birth certificate/latest academic results).
Application forms are available from the NJV website www.njv.com.fj and the NJV office in Suva.
3. Students who already receive other scholarship or education assistance of any kind will not be considered.
4. Tertiary education applicants with successful completion of FSLC (results from 270 and above), Form 7 (results of 250 and above) and USP Foundation year of an average of B+ will be given priority.

Na idusidusi ni veivuke ni vuli ni yabaki 2017

Na i tuvatuva oqo e vakamatata taka na vei yavu eso ena taurivaka na Namosi Joint Venture (NJV) me baleta na porokaramu ni veivuke kina vuli (EAP) me baleta na yabaki 2017.

Na veivuke ena vakarautaki me baleti ira na gonevuli ena yasana vakaturaga ko Namosi, kei na tikina ko Waidina ena yasana ko Naitasiri ka era gadreva na veivuke vakailavo ena vuku ni vuli torocake e Viti.

Na veivuke ena soli ga ena yabaki oqo ka ena qai vakatau tikoga kina kabani na Namosi Joint Venture kevaka ena via tomana ena yabaki ka tarava. Ena rawa tale tikoga me na duidui tiko nai wiliwili ni gonevuli era na vukei ena veiyabaki.

Esa na mai sogo tiko na kena soli na kerekere ni veivuke me baleta na i matai ni wasewase ni vuli (Semester 1) ni 2017 enai ka 24 ni Fepuari 2017.

Ai vola kerekere walega e sega ni sa vakadonui sara kina na nomuni kerekere.

Na ka e gadrevi mai vua e dua e kerekere

1. O koya e biuta yani na nona i vola kerekere ena dodonu me tiko na nona yabaki ni bula ena maliwa ni 18 kina 35.
2. Ko ira taucoko era kerekere mera vakalewena na fomu ni kerekere ni matai ni wasewase ni vuli 2017 ka vakarautaka talega mai na veivola oqo (official invoice/i vola ni sucu/macala ni veitarogi).
Na fomu ni kerekere e rawa ni kunei ena NJV website www.njv.com.fj kei na vale ni volavola ni NJV e Suva.
3. Vei kemuni na sa ciqoma oti tiko na veivuke mai na dua tale na tabana ni veiqaravi e dodonu me matata ni ko ni na sega ni vukei ena veivuke ni vuli oqo.
4. O kemuni na gone vuli o ni rawata na maka e 270 e na Fomu 6 (FSLC), 250 e na Fomu 7 (FSFE) kena vakatagedegede na B+ ena USP Foundation ena soli vei kemuni na matai ni digidigi.

5. Trade course applicants with a minimum of a B+ average in the trade that they wish to pursue will be given priority. First time applicants for trade courses must have a good pass mark in the FSFE or FSLC exams for the subject they intend to pursue.
 6. Continued assistance to existing applicants will be considered based on them maintaining at least a C+ average in their relevant course. This is reviewed every semester and no guarantees of continued assistance beyond any semester are provided.
 7. Applicants from other areas covered under SPL and/or married into Namosi and Tikina Waidina will be considered subject to budget allocation.
 8. Applicants will only be considered for certificate, diploma and undergraduate level studies. Post-graduate applicants will only be considered subject to budget allocation.
5. O kemuni na gonevuli ko ni tiko e na vuli tara - ena soli na matai ni digidigi vei kemuni ka rawata na B+. Na gonevuli e kerekere mai e na matai ni gauna ena vuli vata oqo, me rawata koto na maka vinaka ena leseni ka salavata kei na vuli cakacaka era via taura.
 6. E na vakasamataki ka dikevi na veivuke e vagolei vei ira ka era sa vukei tiko ka era rawata ga na i vakatagedegede na C+. Qo e dau dikevi e na vei wasewase ni vuli ka sega ni vakadeitaki na kena tosoi tikoga na veivuke e na vei wasewase kece.
 7. Na nodra kerekere talega na gone vuli ka kovuti no dra qele ena Laiseni ni Vakdidike (SPL) ka ra vakawati taki e Namosi kei na Tikina o' Waidina ena dikevi tale ga, ia ka na vakatautaki tiko ena levu ni lavo evo ena tobu.
 8. Na veivuke ena dikevi ka vakagolei ga vei ira era goleva nai vakatagedegede ni vuli ka soli kina na Certificate, Diploma, kei na Undergraduate. Ko ira era qarava na vuli ni Postgraduate ena vakatau tiko na nodra vukei ena levu ni lavo ni veivuke ni vuli e vo.

Process

1. The NJV will inform successful and unsuccessful applicants in writing or by telephone.
2. Payments for approved applicants for the semester in question will be processed in line with official invoices provided by the tertiary institution.
3. The NJV will meet with students if required to discuss requirements for the continuation of education assistance.
4. Students are encouraged to inform the NJV of their progress (or challenges) faced in completing their studies.
5. NJV require the most recent course results to determine whether educational assistance will continue or be terminated in the next semester. There are no guarantees of continued assistance beyond the semester.
6. Any decision on whether or not to provide assistance to an applicant is at the discretion of NJV and is final.

Na i tuvatuva ni vei qaravi e na kere veivuke

1. The NJV ena qai volavola se qiri yani vei ira kece na kerekere mai ena vuku ni macala ni nodra kerekere, ena kena vakadonui se sega
2. Na sausaumi vei ira e vakadonui na nodra kerekere, e na qai vakayacori me salavata kei na i vola-tukutuku mai na koro ni vuli e laki vakayacori kina na vuli.
3. Na kabani na NJV e na sota kei ira na gonevuli kevaka e gadrevi me veivosakitaki na kena tomani na veivuke ni vuli.
4. E ra vakauqeti na gonevuli me ra tukutuku lesu mai kina Kabani me baleta na toso ni nodra vuli (se na dredre e so e ra sotava).
5. E na gadreva na Kabani na NJV na macala ni veitarogi me rawa ni vakadeitaka se na tosoi tiko na veivuke se sega.
6. Na vakatulewataki me tosoi tiko na veivuke ni vuli se sega - ena qai nona vakatulewa ga na kabani na NJV.
